


Flow Chart of Web portal

Eligibility for Attendant Accompaniment

Only those passengers who are medically unfit to travel independently shall be permitted to carry one attendant during the journey.

This provision shall be applicable exclusively to:

- Persons with certified disabilities, or
- Passengers suffering from a medical condition requiring assistance during travel.

Such passengers shall be required to upload a valid **Medical Certificate / Disability Certificate** issued by a competent medical authority at the time of booking.

No attendant shall be permitted without submission and verification of the requisite medical documentation, and in all cases, only one attendant per eligible passenger shall be allowed.

STEP 4: PENALTY DECLARATION



Penalty for Non-Reporting / Late Cancellation

In the event that a registered passenger fails to report for the journey on the scheduled date and time, or does not cancel the booking at least 36 (thirty-six) hours prior to the scheduled departure, the passenger shall be liable to pay a penalty of **₹6,000/- (Rupees Six Thousand only)** or 50% of the total cost of the trip, whichever is higher.
